



## Application for Registration or License Commercial Dog or Cat Breeder

**Registration:** To register a commercial dog or cat breeding facility with the Board of Animal Health, complete Part A, include payment of \$50.00, and sign and date the bottom of the application. Return application and payment to the Board of Animal Health.

**Full licensure:** For full licensure of a commercial dog or cat breeding facility with the Board of Animal Health, complete Parts A and B, include payment equal to \$10 per adult breeding animal (minimum \$100) up to a maximum of \$250, sign and date the bottom of the application. Return application and payment to the Board of Animal Health. The initial license period will be from the date of application approval until July 1, 2016.
